Sub : Payment of Grants to Urban Local Bodies outside K.M.D. Area in lieu of taxes realised on trade, professions and callings during the year 2008-2009 (2nd instalment).

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release payment of a sum of Rs.1,37,96,000/- (Rupees One crore thirty seven lakh ninety six thousand) only as grant in lieu of taxes realised on trades, professions and callings to the Urban Local Bodies outside K.M.D. Areas as per enclosed statement for the year 2008-2009 (2nd instalment).

2. The fund sanctioned above will be drawn by the concerned District Magistrate who will disburse the amount to the Urban Local Bodies in his jurisdiction by transfer credit through Local Fund A/c. of this concerned Urban Local Body.

3. The charge is debitable to the head, "3604-Compensation & Assignments to Local Bodies and Panchayati Raj Institution-00-200-Other Miscellaneous Compensation and Assignments-NP-Non-Plan-024-Grants-in-aid to Municipalities/Urban Local Bodies outside K.M.D.Area in lieu of taxes realised on trades, professions and callings-31-Grants-in-aid-02-Other Grants-V" under Demand No.39/MA in the current year's budget i.e. 2008-09.

4. The Grants-in-aid sanctioned in para 1 above is for general purpose grant, which is released to the Urban Local Bodies for payment of non-plan maintenance works like repair of roads etc.

5. Utilisation Certificate is to be furnished by the Urban Local Bodies in terms of Note-2 below S.R. 330A of the Treasury Rules, West Bengal, to the Principal Accountant General (A&E), West Bengal.

6. This order issues in exercise of the powers delegated under Finance Department Memo.No.1818-FB dated 31.12.08.

7. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
