Subject: **Grant of 12th Finance Commission's Award (2009-2010): 2nd instalment.**

The undersigned is directed, by order of the Governor, to say that the Governor has been pleased to sanction payment amounting to Rs. 38,91,37,600/- (Rupees thirty eight crore ninety one lakh thirty seven thousand and six hundred) only as grants-in-aid to the Urban Local Bodies as detailed at col.6 of the Statement annexed hereto for implementation of various development work as per package of programme prepared by each of the Urban Local Body during 2009-2010 for implementation of the 12th Finance Commission Award included under Annual Development Plan of the Urban Local Bodies. Out of the amount released herein, the amount shown in the column 4 of the enclosed statement shall be spent for Solid Waste Management Scheme, that shown in column 5 for Data-base, maintenance of Accounts and other non-SWM scheme.

2. However separate scheme should be drawn for Solid Waste Management distinct from other schemes in terms of the segregation of the Urban Local Bodies -wise fund as shown in the enclosed statement, separate accounts maintained as well as distinctly indicated in the utilization to be furnished.

3. The Director, SUDA, is hereby authorized to draw the amount sanctioned in Para-1 above from the Bidhannagar Treasury by a separate Grants-in-aid Bill under the head of account mentioned herein below, and credit the same to its state-level Fund Transfer Account maintained with the United Bank of India, Sector-V, Salt Lake Branch. Immediately thereafter, the Director, SUDA, will advise the United Bank of India, Sector-V, Salt Lake Branch for transfer of the earmarked fund, as indicated in each case at col.6 of the statement annexed hereto, to the respective Fund Transfer Accounts of the Urban Local Bodies concerned held in different United Bank of India Branches for implementation of the programme.

4. The United Bank of India, Sector-V, Salt Lake Branch, at their earliest opportunity and within a maximum period of one week, will comply with the Advice, through its own electronic network or otherwise, and will also confirm the Director, SUDA, the fact of crediting each of the respective Fund Transfer Accounts of the Local Urban Bodies held in its different Branches.

5. In all cases, the Urban Local Bodies should be informed by the Director, SUDA, by the fastest mode of communication, about such remittance of fund, so that they may monitor the expenditure, subsequently.

The United Bank of India authorities are also required to instruct all the concerned Bank Branches to inform their client Urban Local Bodies instantly about every new amount to be credited in the respective Fund Transfer Accounts.

6. The amounts received through the Fund Transfer Accounts shall be utilized for taking up various work under the 12th Finance Commission funded programmes and not for any other purpose.

7. The designated officials of the Urban Local Bodies authorized to operate Fund Transfer Accounts should maintain separate ledgers.

8. The Urban Local Bodies will be the executing agencies in implementing the programme and will implement the same as per the guidelines for implementation of the programme circulated earlier.

9. The utilization certificate on the lines mentioned in para-2, above, will be furnished by the Urban Local Bodies in terms of Note-2 below S.R. 330A of the Treasury Rules, West Bengal Volume -I and Physical and Financial Progress to the appropriate authorities in the prescribed format.

10. The charge is debitable to the new head, "2217-Urban Development-80-General-800-Other Expenditure-NP-Non-Plan-006-Assistance to Urban Local Bodies as recommended by the Twelfth Finance Commission[MA]-31-Grants-in-aid-02-Other Grants-V" under Demand No.39/MA during the current financial year.

11. This order issues with the concurrence of the Finance Department vide their Un-official No. Gr.'N' 2001 dated 11.01.2010 as well as in terms of this Department Notification No. 514/MA/C-10/1G-4/2007 dated 09.05.2008, regarding 'Faster Mode of Fund Flow', issued with the concurrence of Finance Department U.O. No.945 Gr. 'T' dated 16.07.2007 and U.O. No. 61 Gr. 'T' dated 09.04.2008.

12. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
