
2. The grant-in-aid sanctioned hereinabove will be drawn by the District Magistrates and he will deposit the same in his P.L.A/c and disburse as salaries to the existing regular employees of the urban Local Bodies against sanctioned strength from his end under his jurisdiction.

The charge is debitible to the head, "2217-Urban Development-05-Other Urban Development Schemes-191-assistance to Local Bodies, Corporations, Urban Development Authorities, Improvement boards etc. - NP-Non-Plan-019-Fixed grants to the Municipal Corporation and other Urban Local Bodies, towards salaries of their employees-31-Grants-in-aid-01-Salary Grants-V" under demand No.39/MA in the current year's budget i.e. 2008-2009.

The Utilisation Certificate in respect of the grant to be drawn by the concerned Urban Local Bodies should be furnished in the prescribed form direct to the Principal Accountant General(A&E), West Bengal with a copy to this Department as soon as the amount is drawn and utilised. Submission of utilisation certificate upto December, 2008 will be required for further grants in this respect.
