Subject: **Release of fund for implementing WBSWAN connectivity including INVC facility at 82 non-KMA Urban Local Bodies under Development of Municipal Areas Scheme.**

The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs.2,19,29,900/-(Rupees two crore nineteen lakh twenty nine thousand nine hundred) only in favour of the Change Management Unit(CMU) for implementing WBSWAN connectivity at 82 non-KMA Urban Local Bodies as per the proposal contained in the CMU's U.O. No.CMU-720/2010/68 dated 01.11.2011 and approved by the Department of Information Technology vide their letter No.560-ADS(SM)/IT/O/17/2006 dated 28.12.2011 under Development of Municipal Areas Scheme, as a part of e-governance programme in urban areas.

2. An amount of Rs.2,19,29,900/-(Rupees two crore nineteen lakh twenty nine thousand nine hundred) only is allotted herewith to meet the expenditure mentioned at Para 1.

3. The Accounts Officer, CMU, the Drawing & Disbursing Officer of the Change Management Unit(CMU) is hereby authorised to draw the amount sanctioned in Para 1 above in T.R. Form No.31 from the Bidhannagar Treasury, after it is duly countersigned by the sanctioning authority.


