The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs.3,99,25,000/- (Rupees three crore ninety nine lakh twenty five thousand) only to the Urban Local Bodies as detailed in the enclosed statement as grants for Infrastructure Development and Poverty Alleviation under Basic Minimum Services Programmes.

2. The District Magistrates concerned are authorized to draw the amount sanctioned in para 1 above in T.R. Form No.31 and disburse the same to the concerned Urban Local Bodies by transfer credit to their Local Fund Accounts with the Treasuries concerned for the purpose mentioned above.

3. The scheme will be executed by the concerned Urban Local Bodies strictly adhering to the Guideline circulated earlier.

4. The Utilisation Certificate in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Body to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department, the concerned District Magistrates as well as the State Urban Development Agency.

5. The amount is debitible to the heads of account under Demand No. 39/MA in the current year's budget as detailed below :
