Sub : Payment of Grants on account of Entertainment Tax to Kulti, Bongaon and English Bazar Municipality during 2008-2009 (4th instalment).

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs.34,35,000/- (Rupees Thirty four lakh thirty five thousand) only as grant-in-aid towards Entertainment Tax grant (4th instalment) to the Urban Local Bodies for the year 2008-09 as detailed in the margin.

2. The fund sanctioned above will be drawn by the concerned District Magistrates who will deposit the same in his P.L. A/c and disburse the amounts towards payment of electricity dues or any other dues on priority basis and for payment against cost of establishment of the ULBs after clearing the outstanding dues mentioned above.

3. The charge is debitable to the Head, "3604-Compensation & Assignment to Local Bodies and Panchayati Raj Institution-00-103-Entertainment Tax-NP-Non-Plan-005-Grants-in-aid to Municipal Corporation and other Urban Local Bodies-31-Grants-in-aid-02-Other Grants-V" (MA), under Demand No.39/MA in the current year's budget i.e. 2008-09.

4. The grants-in-aid sanctioned in para 1 above is for general purpose/Non Salary Grant which is released to the Urban Local Bodies for particular purposes of liquidation after reconciliation of outstanding electricity dues of WBSEB/HUDCO., if any on priority basis and for payment against cost of establishment after clearing the dues of aforesaid agencies.

5. The undersigned is further directed to request the ULBs for confirmation of actual outstanding dues of CESC/WBSEB/HUDCO etc. if any, after payment of the amount sanctioned herein and also to indicate the programme of the ULBs to square up the outstanding dues in future, in the event of failure the Government will have no other alternative but to deduct their amount from the next allotments to meet up the outstanding dues.

6. The Utilisation Certificate is to be furnished by the Urban Local Bodies in terms of Note-2 below S.R. 330A of the Treasury Rules, West Bengal, Volume - I to the Principal Accountant General(A&E), West Bengal with a copy to this Department.

7. This order issues in exercise of the power delegated under Finance Dept's Memo No.1818-FB dated 31.12.2008.
