**M E M O**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs.4,21,00,000/- (Rupees four crore twenty one lakh) only to the Urban Local Bodies as detailed in the enclosed statement as grants for Infrastructure Development and Poverty Alleviation under Basic Minimum Services Programmes.

2. The District Magistrates concerned are authorized to draw the amount sanctioned in para 1 above in T.R. Form No. 31 and disburse the same to the concerned Urban Local Bodies by transfer credit to their Local Fund Accounts with the Treasuries concerned for the purpose mentioned above.

3. The scheme will be executed by the concerned Urban Local Bodies strictly adhering to the Guideline circulated earlier.

4. Utilisation Certificate in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Body to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department as well as to the State Urban Development Agency.

5. The charge is debitable to the head of account, "2217-Urban Development-05-Other Urban Development Schemes-192-Assistance to Municipalities / Municipal Councils-SP-State Plan(Annual Plan & Eleventh Plan)-007-Grants to Municipalities for ongoing schemes of erstwhile BMS programmes-V-Voted-31-Grants-in-aid-02-Other Grants" under Demand No. 39/MA in the current year's Budget.

6. This order issues in exercise of the powers delegated under Finance Department Memo. No.1818-F.B. dated 31.12.2008.

7. The Principal Accountant General (A&E), West Bengal and others concerned are being informed.
