Sub : Payment of Grant for maintenance of Civic Services by the Bidhannagar Municipality during 2011-2012 (2<sup>nd</sup> Instalment).

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a grant of **Rs. 75,00,000/- (Rupees seventy-five lakh)** only to the Bidhannagar Municipality for maintenance of Civic Services for 2011-2012.

2. The allotment of a sum of Rs. 75,00,000/- (Rupees seventy-five lakh) only sanctioned herein is placed at the disposal of the District Magistrate, North 24 Parganas who will draw and disburse the same to the Bidhannagar Municipality.

3. The charge will be debitable to the head, "2217-Urban Development-05-Other Development Scheme-192-Assistance to Municipalities/Municipal Council-NP-Non-Plan-006-Grants to Bidhannagar Municipality [MA]-31-Grants-in-aid-GENERAL-02-Other Grants-V" under Demand No. 39(MA) in the current year's budget i.e. 2011-2012.

4. The fact of drawal or non-drawal of the grant during the current financial year, as may happen, should be reported to this Department in good time before the close of the financial year.

5. The Utilisation Certificate in respect of the grant to be drawn by the Municipal Authority should be submitted in the prescribed form directly to the Principal Accountant General (A&E), West Bengal with a copy to the Director of Local Bodies, West Bengal, as soon as the amount is drawn & utilised. The Director of Local Bodies, West Bengal will report to the Department about the position regarding the submission of Utilisation Certificate by the Local Body.

6. This order issues in exercise of the powers delegated under Finance Department memo no: 2450-FB dated 30.12.2011.
