**Sub: Release of Entertainment Tax to Howrah Municipal Corporation during 2011-12 (1<sup>st</sup> instalment)**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of Rs. 83,00,000/- (Rupees Eighty three lakh) only to the Howrah Municipal Corporation as grants on account of Entertainment Tax during the year 2011-12 (1<sup>st</sup> instalment).

2. The fund sanctioned above will be drawn by the Commissioner, Howrah Municipal Corporation in T.R. Form No. 31, after it is duly countersigned by District Magistrate, Howrah.

3. The charge is debit to the head, "3604-Compensation and Assignments to Local Bodies and Panchayati Raj Institution -00-103- Entertainment Tax -NP-Non-Plan-005-Grants-in-aid to the Municipal Corporation and other Local Bodies-31-Grant-in-aid-GENERAL-02-Other Grants-V" (MA) under demand no 39/MA in the current year's vote-on-account budget i.e. 2011-2012

4. The Grants-in-aid sanctioned in para 1 above is for general-purpose/Non Salary grant which is released to the Urban Local Body for payment against cost of establishment and or for liquidation after reconciliation of out standing dues of CESC/WBSEDCL, etc, on priority basis.

5. The Corporation should furnish Utilisation Certificate to the Principal Accountant General (A&E), West Bengal in prescribed form as soon as the grant is drawn and utilised.

6. This order issues in exercise of the powers delegated under Finance Department memo no. 700-FB dated 31.03.2011.


