Sub : **Fixed Grant to the Kolkata Municipal Corporation towards Salaries of their employees for the month of May,2009 with shortfall, if any (on provisional basis).**

Sir,

In continuation of G.O. No.14G/MA/N/C-2/1G-1/2009 dated 24.04.2009, I am directed by order of the Governor to say that the Governor is hereby pleased to sanction and release for payment of a sum of Rs.41,36,55,132/- (Rupees Fortyone crore thirty six lakh fifty five thousand one hundred thirty two) only to the D.D.O. of the Kolkata Municipal Corporation for payment of salaries to their employees for the month of May, 2009 subject to the following conditions :

- 1 Grants shall be utilized towards salaries of the employees of the Kolkata Municipal Corporation who are in position and whose appointments have been approved by the State Government as on 1<sup>st</sup> April, 1986.
- 2 If on verification any material discrepancies in the number of posts sanctioned and the number of employees in position are detected at any later stage appropriate adjustment in grants to be released subsequently on this account will be made. Again all excess drawal/shortfall against Revised Basic Pay as per ROPA-2009 will be adjusted in due course.
- 3 The grant-in-aid sanctioned herein will be drawn by the Controller of Municipal Finance & Accounts, Kolkata Municipal Corporation in T.R. Form No. 31 after it is duly countersigned by the sanctioning authority.
- 4 The charge is debitible to the head, "2217-Urban Development-05-other Urban Development Scheme-191-Assistance to Municipal Corporations, -NP-Non-Plan-019-Fixed Grants to the Municipal Corporations & other Urban Local Bodies towards salaries of their employees-31-Grants-in-aid-01-Salary Grants-V" under Demand No. 39/MA in the current year's budget i.e. 2009-2010.
- 5 The Utilisation Certificate in respect of the grants sanctioned herein should be furnished to the Principal Accountant General (A&E), West Bengal, with a copy to the Department in the prescribed proforma as soon as the grant is utilised for the purpose for which it is sanctioned. Utilisation Certificate up to April,2009 must be produced for further release of fund.
- 6 The Principal Accountant General (A&E), West Bengal/Pay & Accounts Officer, Kolkata Pay & Accounts Office & other concerned are being informed.
- 7 This order issues in exercise of the powers delegated under Finance Department Memo No.2500-FB dated 31.03.2009.
