Sub : Payment of grants under Water Supply Facilities (Spot Sources) in favour of different Urban Local Bodies under State Plan during the year 2011-2012.

The undersigned is directed by order of the Governor, to say that the Governor is pleased to sanction payment of a sum of Rs.7,40,00,000/- (Rupees Seven crore and forty lakh) only to the Urban Local Bodies, as detailed in the enclosed Statement for restoration of damaged tube-wells caused due to heavy rain last year.

2. The fund is released to the concerned Urban Local Bodies who have been identified as heavy rain affected towns by Disaster Management Department, taking into consideration the population of respective Urban Local Bodies as per 2001 census incorporated in the respective category as defined under section 7 of West Bengal Municipal Act,1993, and subject to the condition that before execution of work, detailed list of locations and vetted estimates to be submitted to this Department.

3. The District Magistrates concerned are authorized to draw the amount sanctioned herein in T.R. Form No.31 and disburse the same to the concerned Local Bodies by transfer credit to their Local Fund Accounts with the Treasuries concerned. The Urban Local Bodies will utilize the said amount for the purpose for which it is sanctioned.

4. The Utilisation Certificates in terms of S.R.330A of the Treasury Rules, West Bengal, Volume-I, are to be furnished by the concerned Urban Local Bodies to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department and the concerned District Magistrates. On receipt of the Utilisation Certificates for the amount sanctioned in this connection, further allotment will be considered.

5. The fact of drawal or non-drawal of the grants by the concerned Urban Local Body as may happen, should be reported to this Department in good time before the close of the current financial year.

6. The charge is debitable to the head of account "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporations-SP-State Plan (Annual Plan and eleventh Plan)-005-Development of Municipal Areas-Water Supply facilities (Spot Source) to the Urban Local Bodies outside CMDA-V-Voted-31-Grants-in-aid-GENERAL-02-Other Grants" under Demand No.39 (Department Code-MA), in the current year's Budget.

7. This order issues in exercise of the powers delegated under Finance Department's Memo. No.2450-F.B. dated 30.12.2011 and as and as Finance Department U.O.No.0673 dated 02.08.2011.

8. The Principal Accountant General (A&E), West Bengal and others concerned are being informed.
