Sub : Sanction of Entertainment Tax grant (3rd instalment) during 2011-12 to meet up outstanding electricity dues to WBSEDCL.

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release a sum of **Rs. 5,27,82,000/- (Rupees five crore twenty-seven lakh eighty-two thousand)** only for meeting the electricity dues of Urban local Bodies as per enclosed statement to WBSEDCL on behalf of the concerned ULBs as grants -in-aid.

2. The grants-in-aid as sanctioned above will be drawn by the director, SUDA in T.R. Form No.-48 after it is duly countersigned by the sanctioning authority and will be deposited by transfer credit to the Local Fund Account of SUDA and thereafter a Local Fund Account Payee Cheque equal to the amount of Rs. 5,27,82,000/- only will be issued by the Director, SUDA in favour of WBSEDCL for the above purpose.

3. The charge will be debitable to the head "3604-Compensation and Assignment to Local Bodies and Panchayati Raj Institutions-00-103-Entertainment Tax-NP-Non-plan-005-Grants-in-aid to Municipal Corporation and other Urban Local Bodies-31-Grants -in-aid-GENERAL-02-other grants-V"(MA) under Demand No.: 39/MA in the current years' budget i.e. 2011-2012.

4. The Utilisation Certificate is to be furnished by the ULBs in terms of Note-2 below SR330A of the WB Treasury Rules - Volume-I to the Principal A.G. (A&E), West Bengal with a copy to this Department.

5. This order issues with the concurrence of the Finance Department (vide their U.O. No.: 1845, Gr.-N, Dated: - 10.01.2012 to read with U.O No.: 68, Gr.-R, dated 13.01.2012).
