The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord sanction of payment amounting to Rs.3,35,00,000/- (Rupees three crore thirty five lakh) only as grant-in-aid to the Urban Local Bodies as detailed in the enclosed statement towards partial cost for implementation of the Project as mentioned therein out of the current year's budget provision under Additional Central Assistance for ULBs other than NURM cities.

2. The District Magistrate concerned are authorised to draw the amount sanctioned in the para-1 above and disburse the same to the Urban Local Bodies through transfer credit to the Local Fund Accounts of the Urban Local Bodies concerned with the treasuries concerned for implementation of the programme.

3. The Urban Local Bodies will be the executing agencies in implementing the programme and will implement the same as per guidelines for implementation of the programme circulated earlier.

4. The Utilisation Certificates on the lines mentioned in the foregoing paras, will be furnished by the Urban Local Bodies in terms of SR.330A of the Treasury Rules, West Bengal Volume-I and Physical and Financial Progress to the appropriate authorities in the prescribed format.

5. The charge is debitable to the head of account "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporation-SP-State Plan (Annual Plan and 11th Plan)-050-ACA for ULBs other than NURM cities-31-Grants-in-aid-02-Other Grants" under Demand No.39/MA.

6. The Order issues with the concurrence of the Finance Department vide their U.O.No.2341 Gr.'N' dated 06.02.2009.

7. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
