Subject: Allotment of fund for payment of Subvention to the Kurseong/ Kalimpong Municipalities and Mirik N.A.A. on account of Winter Allowance of their employees for the year 2009-2010 & 2010-2011 from the budget provision of current financial year i.e. 2011-2012.

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction the allotment of a sum of Rs. 2,94,998/- (Rupees two lakh ninety-four thousand nine hundred and ninety-eight) only to the District Magistrate, Darjeeling for payment of 80% subvention to the municipalities on account of Winter Allowance at the uniform rate of Rs. 2,500/- (Rupees two thousand five hundred) only per annum to their whole time employees who are eligible for Winter Allowance for the year 2009-2010 and 2010-2011 noted below.

- The subvention sanctioned above should be drawn by the District Magistrate, Darjeeling and disbursed the same to the Municipalities and Notified Area Authority by transfer credit to the Local Fund Account of the concerned Urban Local Bodies.
- The charge is debitible to the head, "2217-Urban Development-05-Other Development Scheme-192-Assistance to Municipalities / Municipal Councils-NP-Non-Plan-001-Winter Allowance to the employees of the Local Bodies etc.-31-Grants-in-aid-GENERAL-02-Other Grants-V" under demand no. 39/MA in the current year's budget i.e. (2011-2012).
- The Utilization Certificate in respect of the grant sanctioned above should be furnished to the Principal Account General (A&E), West Bengal with a copy to this Department as soon as the amount is drawn and utilised.
- The Principal Accountant General (A&E), West Bengal/ Treasury Officer and others concerned are being informed.


