Subject: **Release of fund for Rapid Assessment Survey for identification of homeless population in six Urban Local Bodies under BMS Programme.**

The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs.4,59,000/-(Rupees four lakh fifty nine thousand) only in favour of the Change Management Unit(CMU) for Rapid Assessment Survey for identification of homeless population in six Urban Local Bodies, viz. Siliguri M.C., Durgapur M.C., Rajpur-Sonarpur Municipality, Bhatpara Municipality, South Dum Dum Municipality and Maheshtala Municipality, in pursuance of the direction of the Hon'ble Supreme Court and on the basis of the decisions taken in the meetings of the State Level Empowered Committee for overseeing, monitoring and coordinating programmes and services for the urban homeless held on 26.12.2011 as communicated by the Department Women & Child Development and Social Welfare vide their letter No.9839-SW/1199-SS/DWCD & SW dated 27.12.2011 and since Change Management Unit has been entrusted to supervise the survey of the urban homeless in the municipal towns noted above and accordingly as per the proposal contained in the CMU's letter No.CMU-751/2011/588 dated 13.12.2011 under Basic Minimum Services Programme.

2. An amount of Rs.4,59,000/-(Rupees four lakh fifty nine thousand) only is allotted herewith to meet the expenditure mentioned at Para 1.

3. The Accounts Officer, CMU, the Drawing & Disbursing Officer of the Change Management Unit(CMU) is hereby authorised to draw the amount sanctioned in Para 1 above in T.R. Form No.31 from the Bidhannagar Treasury, after it is duly countersigned by the sanctioning authority.


4. The Utilisation Certificates in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I are to be furnished by Change Management Unit(CMU) to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department.

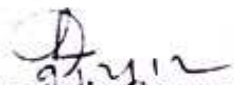
