The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord sanction to the payment of Rs. 27,04,39,000/- (Rupees Twenty Seven crore four lakh and thirty nine thousand) only to the State Urban Development Agency, the State Level Nodal Agency as Additional Central Assistance of the Approved Project Cost for implementation of Integrated Housing & Slum Development Programme (IHSDP) under JNNURM in 11 (eleven) municipalities, vide Government of India, Ministry of Finance, Department of Expenditure, Plan Finance-I Division Order No. F No 59(6)/PF-1/2011-1152 dated 20.12.2011 as shown below:-
