Sub : Release of Grants on account of Taxes on Vehicles to the Municipal Corporations & Other Urban Local Bodies during the year 2008-2009 for emergent Road Repairs(2nd instaiment).

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment on ad-hoc basis, to the Municipal Corporations and other Urban Local Bodies a sum of Rs.6,71,44,800/- (Rupees Six crore seventy one lakh forty four thousand eight hundred) only as per enclosed statement as grant during 2008-2009 on account of taxes on Vehicles as 2nd instalment for emergent road repairs/maintenance..

2. The District Magistrate is herby authorised to draw the amount sanctioned above and disburse the same by transfer credit through Local Fund A/c of concerned Urban Local Bodies.

3. The charge is debitable to the head, "3604-Compensation and Assignments to Local Bodies & Panchayati Raj Institutions -00-106-Taxes on Vehicles-NP-Non-Plan-002-Grants-in-aid to Municipalities (MA)-31-Grants-in-aid-02-Other Grants-V" under Demand No.39/MA in the current year's budget provision.

4. The Grant-in-aid sanctioned above is to be utilised for emergent road repairing/maintenance. Utilisation Certificate is to be furnished by the Municipalities & Other Urban Local Bodies in terms of Note-2 below, S.R.330A of the Treasury Rules, West Bengal, Volume-I, as soon as the grant is drawn and utilised.

5. This order issues in exercise of the powers delegated under Finance Department Memo. No. 1818-FB dated 31.12.08.

6. The Principal Accountant General (A&E), West Bengal and others are being informed.




