**Sub : Release of fund under CRF to the Urban Local Bodies for restoration of infrastructure damaged by heavy rain/ flood/land slide during 2008.**

**M E M O**

The undersigned is directed, by order of the Governor, to say that the Governor has been pleased to sanction payment of a sum of Rs.1,84,18,000/- (Rupees One crore eighty four lakh and eighteen thousand) only in favour of 4(four) Urban Local Bodies, as detailed in the enclosed statement for immediate restoration of infrastructure like Bituminous Rd./Morum Rd./Culvert/Resinking of tubewells/Drain etc., the Urban local Bodies having been affected by heavy rain/flood/land sliding during 2008 against the requirements as verified by the Municipal Engineering Directorate, West Bengal. The Urban Local Bodies should strictly adhere to the schemes as verified by the Municipal Engineering Directorate as well as to the schedule of rates indicated by it.

2. The District Magistrate concerned are hereby authorised to draw the amount sanctioned in para-1 above in Simple Receipt Form (New T.R. Form 31) and disburse the same to concerned Urban Local Bodies within his jurisdiction, by transfer credit to the Local Fund Account of the said Local Body with the respective Treasuries.


3. The schemes are to be taken up by the Urban Local Bodies after the same have been vetted by the Municipal Engineering Directorate, which should also supervise the schemes and countersign the Utilization Certificates.

4. The District Magistrate concerned are required to obtain Utilisation Report in respect of the fund sanctioned herein from the Urban Local Bodies in the prescribed format, which has already been provided, specially pertaining to Sl. No.9 and 16 thereof and to send a copy of the same direct to the Disaster Management Department and also a copy to this Department by 31<sup>st</sup> March, 2009 positively after satisfying himself about the authenticity and accuracy of the same.

5. The receipt of CRF in future will strictly depend on timely submission of the Utilisation Certificate, as indicated in the foregoing para. In this respect the guideline circulated may be referred to.

6. The fact of drawal/non drawal of the fund by the Urban Local Bodies should be reported to this Department as early as possible.

7. The charge is debitable to the head "2245-Relief on Account of NC-02-193-NP-Non Plan-001-31-Grants-in-aid-02-Other Grants-V-Voted" under Demand No.47 from the Budget Provision of Disaster Management Department. The excess expenditure over the budget provision will be met by way of re-appropriation or otherwise in due course.
