'Pension' for the Municipal Pensioners at the
revised rate during the year 2011-2012 (2nd instalment).

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction for the payment of a sum of Rs. 5,03,96,721/-(Rupees Five crore three lakh ninety six thousand seven hundred and twenty one) only to the Urban Local Bodies on adhoc basis as per allotment in the enclosed statement as 40% of total requirement (Basic Pension+Dearness Relief) of Pension to the Pensioners of the Urban Local Bodies for the year 2009-10 during the financial year i.e. 2011-2012.


2. The District Magistrate concerned is hereby authorised to draw the grants sanctioned above and disburse the same to the Urban Local Bodies concerned by transfer credit through Local Fund Account of the concerned Urban Local Bodies in favour of the Pensioners who have received the P.P.O. for drawal of their pension.

3. The charge will be debitable to the head "2071-Pensions and other Retirement Benefits-01-Civil-110-Pension of Employees of Local Bodies-NP-Non-Plan-001- Provision for payment of pension of employees of Local Bodies-04-Pension/Gratuities-V' under demand no. 18/Finance (Audit) Department in the current year's Vote -on-Account budget i.e. 2011-2012.

4. Utilisation Certificate is to be furnished by the Urban Local Bodies in the prescribed form direct to the Principal Accountant General (A&E), West Bengal, with a copy to this Department positively, as soon as the amount is drawn and utilised.

5. This order issues in exercise of the Powers delegated under Finance Department Memo No. 700-FB dated 31.03.2010.

6. The Principal Accountant General (A&E), West Bengal /Treasury Officer and other concerned are being informed.
