Sub: Release of Grant of Entertainment Tax to Krishnagar Municipality during the year 2011-'12 (4th instalment) for payment of arrear family pension & gratuity to the family of deceased retired employee of Krishnanagar Municipality.

---

1. WHEREAS the State Government sanctions non-salary grant on account of Entertainment Tax to the Urban Local Bodies for, inter alia, payment towards cost of establishment.

AND WHEREAS in terms of provisions of clause (j) of sub-rule (1) of rule 2 of the West Bengal Municipal (Employees' Death-cum-Retirement Benefits) Rules, 2003 (hereinafter referred to as the said rules) the term 'Pension' includes gratuity and in terms of provision of sub-rule (1) of rule 31 of the said rules, pension under the said rules shall be paid by the Municipality from its' own fund;

AND WHEREAS Santi Harijan wife of the deceased retired employee of Krishnanagar Municipality (hereinafter referred as the said petitioner) in the district of Nadia due to non-receipt of arrear family pension and gratuity, as per provision of the said rules, approached Hon'ble High Court at Calcutta, and Hon'ble High Court in the order dated 02.09.2009, against W.P.No. 15381 (W) of 2009 directed the Krishnagar Municipality to release the arrear family pension and gratuity payable to the petitioner,

AND WHEREAS the Krishnagar Municipality calculated an amount of Rs. 2,02,402/- by way of family pension and an amount of Rs 3,644/- by way of gratuity for making payment to the said petitioner as per orders of Hon'ble High Court, and expressed their inability to pay the said amount from their own fund (vide memo no. 3833/13-1/11dated 01.12.11) and approved the State Government for making payment;

2. The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs.2, 06,043/- (**Rupees two lakh six thousand and forty-three**) only as the grant on account of Entertainment Tax Grant (4<sup>th</sup> instalment) to the concerned Urban Local Body.

3. The fund sanctioned above will be drawn by the concerned District Magistrate who will disburse the amount to the Krishnagar Municipality in his jurisdiction by transfer credit through L.F.A./C of the concerned Urban Local Bodies and will impress upon the Krishnagar Municipality to make payment of arrear family pension and gratuity as directed by Hon'ble High Court at Calcutta to the said petitioner.

4. The charge is debitible to the head, "3604-Compensation and Assignments to Local Bodies and Panchayati Raj Institutions-00-103-Entertainment Tax-NP-Non-Plan-005-Grants-in-aid to Municipal Corporations and other Urban Local Bodies - 31-Grants-in-Aid-GENERAL-02-Other Grants-V" (MA) under Demand No. 39/MA in the current year's vote-on-account budget i.e. 2011-2012.

5. The Utilisation Certificate is to be furnished by the Urban Local Bodies in terms of Note -2 below SR 330A of the Treasury Rules, West Bengal, Volume-I to the Principal Accountant General (A&E), West Bengal with a copy to this Department.

6. This order issues in exercise of the powers delegated under Finance Department Memo No. 2450 – FB dated 30.12.2011.

7. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
