Sub : Release of Grants on account of Taxes on Vehicles to the Municipal Corporations and Other Urban Local Bodies during the year 2009-2010 for emergent Road Repairs (2nd instalment).

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment on ad-hoc basis, to the Municipal Corporations and other Urban Local Bodies a sum of Rs.7,31,30,400/- (Rupees Seven crore thirty one lakh thirty thousand and four hundred) only as per enclosed statement as Grant during the year 2009-2010 on account of taxes on Vehicles as 2nd instalment for emergent road repairs/maintenance.

2. The District Magistrate is hereby authorised to draw the amount sanctioned above and disburse the same by transfer credit through the Local Fund Account of concerned Urban Local Bodies.
3. The charge is debitable to the head, "3604-Compensation and Assignments to Local Bodies and Panchayati Raj Institutions - 00-106-Taxes on Vehicles-NP-Non-Plan-002-Grants-in-aid to Municipalities (MA)-31-Grants-in-aid-02-Other Grants-V" under Demand No.39/MA in the current year's budget provision.
4. The Grants-in-aid sanctioned above is to be utilised for emergent road repairing/maintenance. Utilisation Certificate is to be furnished by the Municipalities and other Urban Local Bodies in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, Volume-I, as soon as the grant is drawn and utilised, with a copy to this Department.
5. This order issues in exercise of the powers delegated under Finance Department Memo.No.2100-FB dated 31.12.2009.
6. The Principal Accountant General (A&E), West Bengal and others are being informed.


