(on ad-hoc basis) from the budget provision of current financial year, i.e. 2008-2009.**

The undersigned is directed by order of the governor to say that the Governor is pleased to sanction the allotment of a sum of Rs.9,90,000/- (Rupees Nine lakh & ninety thousand) only to the District Magistrate, Darjeeling for payment of 80% subvention to the Municipalities and the Notified

Area Authority on account of Winter Allowance at the uniform rate of Rs.1500/- (rupees One thousand five hundred) only per annum to their whole time employees who are eligible for Winter Allowance for the year 2006-2007 and 2007-2008 as noted in the margin, on ad-hoc basis.

The subvention sanctioned above should be drawn by the District Magistrate and disbursed to the Municipalities and Notified Area Authority on submission of utilisation certificates in respect of grants sanctioned in the previous G.O.No.279G/MA/N/C-2/1G-14/2006 dated 30.11.2007 and 451G/MA/N/C-2/1G-14/2006 dated 18.03.2008.

3. The charge is debitable to the head "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Local Bodies, Corporation, Urban Development Authorities, Town Improvement Boards etc.-NP-Non-Plan-003-Winter Allowances to the employees of the Local Bodies etc.-31-Grants-in-aid-02-Other Grants-V" under Demand No.39/MA in the budget of current financial year (2008-2009).

4. The Utilization Certificate in respect of the grant sanctioned above should be furnished to the Principal Accountant General (A&E), West Bengal, with a copy of this Department.

5. The Principal Accountant General (A&E), West Bengal, the Treasury Officer and other concerned are being informed.
