Sub : Allotment of Fixed Grant to the Municipal Corporation and other Urban Local Bodies towards salaries of their employees (Excluding Kolkata Municipal Corporation & Howrah Municipal Corporation) for the month of February, 2009 with arrear, if any.

In continuation of Government Order No.286G/MA/N/C-2/1G-1/2008 dt.20.01.2009 the undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment of a sum of Rs.11,72,89,977 /- (Rupees Eleven crore seventy two lakh eighty nine thousand nine hundred seventy seven) only to the Urban Local Bodies as stated against each in the enclosed statement the grant towards salaries of their employees in the revised scale of pay and allowances as per ROPA 1998 for the month of February, 2009 with arrears, if any.

2. The District Magistrate concerned is hereby authorised to draw the amount sanctioned herein above and disburse the same to the concerned Urban Local Bodies by transfer credit through the Local Fund Account of the concerned Urban Local Bodies.
3. The charge is debitable to the head, "2217-Urban Development-05-Other Development Scheme-191-Assistance to Local Bodies-Corporation-Urban Development Authorities Improvement Boards etc.-NP-Non-Plan-019-Fixed Grants to the Municipal Corporation & Other Local Bodies towards salaries of their employees-31-Grants-in-aid-01-Salary Grants-V" under Demand No.39/MA in the current year's budget 2008-2009.
4. The Utilisation Certificate in respect of the grant to be drawn by the Local Body should be submitted in the prescribed form directed to the Principal Accountant General (A&E), West Bengal with a copy to the undersigned, as soon as the amount is drawn and utilised.
5. Utilisation Certificate upto January, 2009 shall be furnished by the concerned Urban Local Bodies failing which further allotment will remain withheld.
6. The Principal Accountant General(A&E), West Bengal/Treasury Officer and other concerned are being informed.
7. This order issues in exercise of the power delegated under Finance Department Memo No.1818-FB dated 31.12.2008.
