Sub: Release of Grant on account of Taxes on Vehicles to Kolkata Municipal Corporation for the year 2011-12 (2nd Instalment).

The undersigned is directed by order of the Governor to say that the Governor is hereby pleased to sanction and release for payment to the D.D.O., Kolkata Municipal Corporation, on ad-hoc basis of a sum of Rs. 4,81,59,600/- (Rupees four crore eighty-one lakh fifty-nine thousand and six hundred) only as grant on account of Taxes on Vehicles during the year 2011-2012 (2nd instalment).

2. The grant will be drawn by the Municipal Commissioner in T.R. Form No. 31 and also disbursed by him. He will also act as D.D.O. for drawal of Grants-in-aid Bills including transfer credit bills in respect of Local Fund Account and the Controller of Municipal Finance & Accounts (C.M.F.A.) will act as the operator of local Fund Account for signing L.F. Cheques from the Kolkata Pay and Accounts Office-II. He is requested to make arrangement for submission of Utilisation Certificate as soon as the grant is drawn and utilised.

3. The charge is debitable to the head, "3604-Compensation & Assignment to Local Bodies and Panchayati Raj- Institutions-00-106-Taxes on Vehicles-NP-Non-Plan-001-Grants-in-aid to Kolkata Municipal Corporation (MA)-31-Grants-in-aid-GENERAL-02-Other Grants-V" under Demand No.39/MA in the current year's budget. i.e. 2011-2012.

4. The Grants-in-Aid sanctioned in para 1 above is a general purpose grant which is released to the Kolkata Municipal Corporation for taking up of various maintenance works like repair of roads, riverfront beautification, improvement of footpath, illumination of important places, works for parks and squares etc.

5. Utilisation Certificate is to be furnished by Kolkata Municipal Corporation in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, Volume-I, accordingly.

6. This order issues in exercise of the powers delegated under Finance Department Memo No. 2450-FB dated 30.12.2011.

7. The Pay and Accountant Officer, Kolkata Pay & Accounts Office-I, 81/2/2, Phears Lane, Kolkata - 700 012 and the Accountant General, West Bengal are being informed.
