**Sub : Payment Grants to Urban Local Bodies on account of Arrear/Current 'Relief of Pension'
for the Municipal Pensioner at the revised rate during 2009-2010.**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for the payment of a sum of Rs.1,49,41,518/- (Rupees One crore forty nine lakh forty one thousand five hundred and eighteen) only to the Urban Local Bodies as per allotment in the enclosed statement as arrear/current grant for payment of 'Relief on Pension' to the pensioners of the Urban Local Bodies during the financial year 2009-2010.

2. The District Magistrate concerned is hereby authorised to draw the grants sanctioned above and disburse the same to the Urban Local Bodies concerned by transfer credit through Local Fund Account of the concerned Urban Local Bodies in favour of the Pensioners who have received the P.P.O. for drawal of their pension.

3. The charge is debitable to the head, "2071-Pensioners and Other Retirement Benefits-01-Civil-110-Pension of Employees of Local Bodies-NP-Non-Plan-001-Provision for payment of pension to employees of Local Bodies-04-Pension/Gratuities-V" under Demand No.18, Finance (Audit) Department in the current year's vote-on-account budget.

4. Utilisation Certificate is to be furnished by the Urban Local Bodies in the prescribed form direct to the Principal Accountant General (A&E), West Bengal with a copy to this Department positively as soon as the amount is drawn and utilised.

5. This order issues in exercise of the powers delegated under Finance Department Memo. No.2100-FB dated 31.12.2009.

6. The Principal Accountant General(A&E), West Bengal/Treasury Officer and other concerned are being informed.


