Sub: Allotment of arrear pay and allowances in respect of Sri Samir Baidya under Jaynagar-Mazilpur Municipality for the period from 14-01-2000 to 31.03.2008.

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment of a sum of Rs. 44,197/- for arrear pay and allowances (Rupees forty-four thousand one hundred and ninety-seven) only to Sri Samir Baidya under Jaynagar-Mazilpur Municipality for the period from 14.01.2000 to 31.03.2008 in compliance with the order of the Hon'ble High Court, Calcutta (W.P.13751 (W) of 2007 dated 12.09.2007 in the matter of Samir Baidya -Vs- The State of West Bengal & ors).

2. The District Magistrate concerned is hereby authorised to draw the amount-sanctioned hereinabove and disburse the same to the concerned Urban Local Body by transfer credit through the Local fund Account of the concerned Urban Local Body only.

3. The salary grant is debitable to the head, "2217-Urban Development-05-Other Urban Development Schemes-192-Assistance to Municipalities/Municipal Councils-NP-Non-Plan-007-Fixed Grants to the Municipalities towards Salaries of their employees-31-Grants-in-aid-GENERAL-01-Salary Grants-V" under Demand No.39/MA in the current year's vote-on-account budget i.e. 2011-2012.

4. The Utilisation Certificate in respect of the grant to be drawn by the Local Body should be submitted in the prescribed form in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, Volume-I, direct to the Principal Accountant General (A&E), West Bengal, Volume-I, direct to the Principal Accountant General (A&E), West Bengal with a copy to the undersigned, as soon as the amount is drawn & utilised.

5. The Principal Accountant General (A&E), West Bengal / Treasury Officer and other concerned are being informed.
