Subject: - Sanction of grants to the State Election Commission, West Bengal, for the use of West Bengal State Election Commission and for sub-allotment to the DMEO and D.M in connection with the Municipal General Election to be held in the month of December, 2011 in 4 (four) hill Urban Local Bodies

Sir,

I am directed by order of the Governor to say that the Governor is pleased to sanction a sum of Rs. 60.00 lakh (Rupees Sixty lakh) only and to allot the same to the Secretary, State Election Commission, West Bengal for the use of West Bengal State Election Commission and for sub-allotment to the DMEO and DM in connection with the Municipal Election to be held in the month of December, 2011 in 4 (four) hill Urban Local Bodies.

2. The concerned District Municipal Election Officer will act as Drawing and Disbursing Officer for this purpose. The Accounts Officer, State Election Commission West Bengal is hereby authorized to draw necessary bill for this grants-in-aid bill form (T.R. Form No. 48) of West Bengal Treasury Rules, Volume-II from the Kolkata Pay and Accounts Office.

3. The Secretary, West Bengal State Election Commission is also hereby authorized to allow the District Magistrate to make appropriate sub-allotment in favour of the Sub divisional Officers concerned for drawing and disbursement of the grant as and when considered necessary. Necessary bill for this grant will be drawn in grants-in-aid bill form (T.R. Form No. 48) of West Bengal Treasury Rules, Volume-II.

4. The District Magistrate shall submit the Utilisation Certificates in respect of the aforesaid grant in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I to the Principal Accountant General (A&E), West Bengal with a copy of West Bengal State Election Commission and to this Department in due course. On receipt of the Utilisation Certificates for the amount sanctioned in this connection, further allotment will be considered by the West Bengal State Election Commission.

5. The amount is debitable to the heads of account under Demand No. 39/MA in the current year's budget i.e.2011-2012 as mentioned below:


