Subject: Release of 50% of fund as 1st instalment of Third SFC in favour of Urban Local Bodies for execution of development schemes with grant-in-aid made available as Annual Provision under Third State Finance Commission's Grant for the financial year 2011-2012.

MEMO

The undersigned is directed, by order of the Governor, to say that the Governor is pleased to sanction payment of a sum of Rs. 74,35,27,500/- (Rupees seventy four crore thirty five lakh twenty seven thousand and five hundred) only to the Urban Local Bodies as detailed in the enclosed statement for execution of development schemes as per the Third State Finance Commission's Grant for the financial year 2011-2012.

2. The fund will be utilized by the Urban Local Bodies as per Para 2 of the order issued by the Department vide no. 153(19)/MA/C-10/1G-1/2010 (FS) dated 24.09.2010 read with 165/MA/C-10/1G-1/2010 (FS) dated 30.09.2010.

3. The District Magistrates concerned are hereby authorized to draw the amount sanctioned herein in T.R. Form No.31 and disburse the same to the concerned Urban Local Bodies by transfer credit to their local fund accounts with the Treasuries concerned.

In case of Kolkata Municipal Corporation, Municipal Commissioner, Kolkata Municipal Corporation will draw the amount sanctioned above in TR Form No. 31 from the Pay & Accounts Officer, Kolkata Pay and Accounts Office II, P-1, Hyde Lane, Kolkata - 700073 after it is duly countersigned by the sanctioning authority and through transfer credit to the Local Fund Account No. "8448-00-102-001" of Kolkata Municipal Corporation for the purpose mentioned above.
