The charge is debitable to the head, "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporation-NP-Non-plan-020-Dearness Concession to the Employees of Municipal Corporation and other Urban Local Bodies in KMDA & Non-KMDA. Areas-31-Grants-in-Aid-01-Salary Grants-V" under Demand No.39/MA in the current year's budget i.e.2009-2010. Any excess or shortfall against revised basic pay as per ROPA-2009 will be adjusted in due course.

The Utilisation Certificate in respect of the grant to be drawn by the Kulti/Bongaon/English Bazar Municipality should be furnished in the prescribed form direct to the Pr.Accountant General (A&E), W.B., with a copy to the undersigned, as soon as the amount is drawn and utilised. Submission of Utilisation Certificate upto January , 2010 will be required to release further grants in this regard.
