The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs.39,80,000/- (Rupees thirty nine lakh eighty thousand) only to the Urban Local Bodies for construction / extension / renovation of their Office Buildings, as the case may be as per representations received, as detailed in the enclosed statement.

2. The District Magistrates concerned are authorised to draw the amount sanctioned in para 1 above in T.R. Form No.31 and to disburse the same to the concerned Urban Local Bodies by transfer credit to their Local Fund Accounts with the Treasuries concerned.

3. The Utilization Certificates in terms of S.R.330A of the Treasury Rules, West Bengal, Volume-I are to be furnished by the concerned Urban Local Bodies to the Principal Accountant General(A & E), West Bengal with copies endorsed to this department, the concerned District Magistrates as well as the State Urban Development Agency.

4. The fact of drawal / non-drawal of the grant by the concerned local bodies, as may happen, should be reported to this Department immediately. Further fund, if at all, can be released only on receipt of utilization certificate of earlier and this allotment from the Urban Local Bodies.

5. The amount is debitable to the head of account, "2217-Urban Development-80-General-800-Other Expenditure-SP-State Plan(Annual Plan & Eleventh Plan)-002-Construction of Municipal Buildings-V-Voted-35-Grants for creation of Capital Assets" under Demand No. 39/MA in the current year's vote-on-account Budget.

6. This order issues in exercise of the powers delegated under Finance Department Memo. Nos.700-F.B. dated 31.03.2011 and 1127-F.B. dated 31.05.2011.
