Sub: **Release of grants to the Kolkata Municipal Corporation on account of 'Pension' to the municipal Pensioners during 2012-2013.**

The undersigned is directed by order of the Governor to say that the Governor is hereby pleased to sanction and release for payment of a sum of Rs. 21,55,97,779/- (Rupees Twenty one crore fifty five lakh ninety seven thousand seven hundred seventy nine) only to the Kolkata Municipal Corporation as grants on ad-hoc basis towards residual payment of 40% of total requirement (Basic Pension + Dearness Relief) of pension on the revised scale of pay to the pensioners of Kolkata Municipal Corporation for the year 2010-2011 as communicated vide their letter no. Con/Com/263/2011-12 dated 19.10.2011 during this financial year i.e. 2012-13.

2. The Grant-in-aid sanctioned herein above will be drawn by the Municipal Secretary, Kolkata Municipal Corporation in T.R. Form No. 31 and also disbursed by him.

3. The charge is debitable to the head, "2071-Pensions and other Retirement Benefits-01-Civil-110-Pension of Employees of Local Bodies-NP-Non-Plan-001-Provision for payment of pension of Employees of Local Bodies-04-Pension/Gratuities-V" under Demand No. 18/Finance (Audit) in the current year's budget i.e. 2012-2013. The additional amount will be met by re-appropriation or otherwise in due course.

4. Utilization Certificate is to be furnished by the Kolkata Municipal Corporation in the prescribed form directly to the Principal Accountant General (A&E), West Bengal with a copy to this Department as soon as the amount is drawn and utilized.

5. This order issues with the concurrence of Finance Department (vide their U.O. No. 2277, Gr - 'N' dated 13.02.2013 to read with U.O. No. 0457, Gr - 'R' dated 19.02.2013).

6. The Principal Accountant General (A&E), West Bengal and the Kolkata Pay & Accounts Office II are being informed.
