The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs.10,00,000/- (Rupees ten lakh) only to the Urban Local Bodies as detailed in the enclosed statement as grants for Basic Minimum Infrastructure Development under Basic Minimum Services Programmes.

2. The District Magistrate concerned is authorized to draw the amount sanctioned in para 1 above in T.R. Form No.31 and disburse the same to the concerned Urban Local Bodies by transfer credit to their Local Fund Accounts with the Treasuries concerned for the purpose mentioned above.

3. The scheme will be executed by the concerned Urban Local Bodies strictly adhering to the Guidelines circulated earlier.

4. The Utilisation Certificate in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Body to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department, the concerned District Magistrate as well as the State Urban Development Agency.

5. The amount is debit to the heads of account under Demand No. 39/MA in the current year's budget, by way of re-appropriation or otherwise, as detailed below :
