Subject: **Release of fund under 'Employment Generation in Urban Areas' Scheme in order to generate employment among the urban poor for the year 2009-2010.**

MEMO

The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs. 2,40,53,725/- (Rupees two crore forty lakh fifty three thousand seven hundred and twenty five) only to the Urban Local Bodies as detailed in the enclosed statement for implementation of the above mentioned scheme as per guidelines bearing no. 37-S/05 dated 30.09.2005 and circulated earlier vide letter no. 42-S/2005 dated 30.09.2005 for generation of employment among the urban poor.

2. The District Magistrates concerned are authorized to draw the amount sanctioned in para 1 above in T.R. Form No. 31 and disburse the same to the concerned Urban Local Bodies by transfer credit to their local fund accounts with the treasuries concerned for implementation of the Programme in accordance with the guidelines issued by the Government for the purpose.

3. The charge is debit to the heads of account under Demand No. 39/MA in the current year's budget, as detailed below:-

4. The scheme will be executed by the Urban Local Bodies as Nodal Agency as per the guidelines circulated earlier.

5. Utilization Certificates in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I, are to be furnished by the Urban Local Bodies regularly to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department, concerned District Magistrates as well as the State Urban Development Agency.

6. A list of schemes undertaken showing its name, location, estimate and expenditure incurred should invariably be furnished to SUDA to facilitate release of further funds under this programme in future.

7. The fact of drawal / non-drawal of the grant by the concerned local bodies, as may happen, should be reported to this Department immediately. Further fund, if at all, can be released only on receipt of Utilization Certificate of earlier and this allotment from the Urban Local Bodies.

8. This order issues with the concurrence of the Finance Department vide their U.O. Nos. Gr.'N' 3357 dated 25.03.2010 and Gr.'R' 146 dated 25.03.2010 in relaxation of the powers delegated under Finance Department Memo No. 2100-F.B. dated 31.12.2009.

9. The Principal Accountant General (A&E), West Bengal and others concerned are being informed.


