ORDER

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord sanction and release a sum of Rs. 13,17,38,000/- (Rupees thirteen crore seventeen lakhs thirty eight thousand) only to Kolkata Municipal Corporation under "Direct Payment Procedure" for implementation of Kolkata Environmental Improvement Investment Programme (KEIIP)-Project-1 (Asian Development Bank assisted programme under Loan No. 3053-IND).

2. The amount has been released in favour of the State Government being the Loan component of Additional Central Assistance for the aforesaid project payable in the year 2014-2015 under Direct Procedure on back to back basis as 100% loan by the Department of Expenditure, Plan Finance-I Division, Ministry of Finance, Government of India vide their following sanction letter :-

5. The terms and conditions of loan shall be guided by the Onlending Agreement executed between the State Government and Kolkata Municipal Corporation on 30.05.2014.
