In continuation to the G.O. No. 40/MA/N/C-2/1G-10/2010 dated 11.4.2011, the undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release a grant of Rs. 10,22,64,370/- (Rupees Ten crore twenty two lakh sixty four thousand three hundred and seventy) only being the balance amount out of total entitlement of Rs. 35,22,64,370/- to Kolkata Municipal Corporation for the purpose of payment of their dues to C.E.S.C. Ltd. for the months of August, 2010 to October, 2010.

2. The grants-in -aid as sanctioned above will be drawn by the Municipal Commissioner, Kolkata Municipal Corporation in T.R. Form No. 31 after it is duly countersigned by the sanctioning authority.
3. Grants shall be utilised towards payment of electricity dues to C.E.S.C. Ltd.
4. The charge is debitable to the head of Account "2217-Urban Development-80-General-800-other expenditure-NP-Non-plan-001-Grants to K.M.C./H.M.C. for adjustment of energy bills of CESC[MA]-31-Grants-in-aid-GENERAL-02-other grants" under demand No. 39/MA towards reimbursement in the current year's (i.e. 2011-2012) Vote-on-Account budget.
5. The utilisation certificate will be furnished by the Kolkata Municipal Corporation in terms of Note-2 below SR 33A of the Treasury Rules, West Bengal, Volume-I and physical and financial progress of the appropriate authorities in the prescribed format.
6. This order issues in concurrence of the Finance Department vide their U.O. No. 0278 Gr-N dated 15.06.2011 to read with U.O. No. 07 Gr-R dated 16.06.2011.
