and Basic Minimum Infrastructure**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs.14,25,00,000/- (Rupees fourteen crore twenty five lakh) only to the Urban Local Bodies as detailed in the enclosed statement as grants for Improvement of Slum Level and Basic Minimum Infrastructure such as making provisions of drinking water, repairing of roads, housing for urban poor etc. particularly in slum areas under Basic Minimum Services Programme.

2. The District Magistrates concerned are authorized to draw the amount sanctioned in para 1 above in T.R. Form No.31 and disburse the same to the concerned Urban Local Bodies by transfer credit to their Local Fund Accounts with the Treasuries concerned for the purpose mentioned above.

3. The scheme will be executed by the concerned Urban Local Bodies strictly adhering to the Guideline circulated earlier and after vetting the plans and estimates by appropriate technical authority.

4. The Utilisation Certificates in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I are to be furnished by the concerned Urban Local Bodies to the Principal Accountant General (A&E), West Bengal with copies endorsed to the concerned District Magistrates as well as the State Urban Development Agency. The vetted estimates of the schemes are to be furnished by the concerned ULBs to this Department along with utilisation certificates as per S.R. 330A.

5. The amount is debitible to the heads of account under Demand No. 39/MA in the current year's vote-on-account budget as detailed below :
