Subject: **Allotment of fund in favour of Mirik Notified Area Authority for implementation of various Schemes under Development of Notified Areas Scheme.**

The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs.94,75,000/- (Rupees ninety four lakh seventy five thousand) only in favour of Mirik Notified Area Authority for "Reconstruction and maintenance of 24 Nos. of bituminous roads in different wards" as per proposal sent by the Notified Area Authority vide letter No.89/I-4/12/MM dated 17.03.2012 under Development of Notified Areas scheme.

2. The District Magistrate concerned is authorised to draw the amount sanctioned in para 1 above in T.R. Form No. 31 and disburse the same to the concerned Urban Local Body by transfer credit to its Local Fund Account with the Treasury concerned for the purpose mentioned above.

3. The Utilisation Certificate in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Body to the Principal Accountant General (A&E), West Bengal with copy endorsed to this Department and the concerned District Magistrate.

4. A list of the schemes undertaken showing their names, locations, estimates and expenditure incurred should invariably be furnished to this Department.

5. The amount is debitible to the head of account "2217-Urban Development-05-Other Urban Development Schemes-193-Assistance to Nagar Panchayats/ Notified Area Committees or equivalent thereof -SP-State Plan(Annual Plan and Eleventh Plan)-006-Development of Notified Areas -V-Voted-31-Grants-in-aid-GENERAL-02-Other Grants" under Demand No. 39/MA in the current year's budget.

6. This order issues in exercise of the powers delegated under Finance Department Memo. No.2450-F.B. dated 30.12.2011 and with the concurrence of the Finance Department vide their U.O. No.Gr.'N'0673 dated 02.08.2011.


