Sub: Allotment of funds for **UIDSSMT** from **State Share**, being additional amount required to supplement the enhanced cost due to cost escalation.

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord sanction to the payment of Rs 23,34,96,000/- (Rupees twenty three crore thirty four lakh ninety six thousand) only to the State Urban Development Agency, the State Level Nodal Agency for implementation of UIDSSMT programme under JNNURM as Additional State Share to supplement the enhanced cost for the approved schemes under UIDSSMT as per proposal sent by SUDA, vide their U.O. No. SUDA-234/2011 dated 16.12.2011, due to cost escalation as approved by Finance Department vide their U.O. No. Gr. 'N' 2898 dated 30.03.2012.

2. The grants-in-aid sanctioned above may be drawn by the Director, State Urban Development Agency in T.R. Form No. 31 after it is duly counter-signed by the sanctioning authority. The amount is to be paid by Account Payee Cheque in favour of "State Urban Development Agency". The amount so drawn will be released by SUDA in favour of concerned Urban Local Bodies to meet up the escalated cost.

3. The utilization certificate in the format for the amount should be furnished to the Principal Accountant General (A&E), West Bengal, Treasury Buildings, Kolkata-700001 with a copy to this Department as early as possible after satisfying the authenticity and accuracy of the same.


