Sub : Payment of grants under Water Supply Facilities (Spot Sources) in favour of Kandi Municipality under State Plan during the year 2011 – 2012.

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs. 5,90,000/- (Rupees five lakh ninety thousand) only to the Kandi Municipality for sinking of one 300mm X 200mm dia deep tube-well, to overcome water scarcity, as per proposal vide Ref. No. 172/MLA/K-AC/12 dated 24.03.12.

2. The District Magistrate concerned is authorized to draw the amount sanctioned herein in TR Form No. 31 and disburse the same to the concerned Urban Local Body by transfer credit to its Local Fund Account with the Treasury concerned. The Urban Local Body will utilize the said amount for the purpose for which it is sanctioned.

3. The Utilisation Certificate in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Body to the Principal Account General(A&E), West Bengal with copies endorsed to this Department and the concerned District Magistrate. On receipt of the Utilisation Certificate for the amount sanctioned in this connection, further allotment will be considered.

4. The fact of drawal or non-drawal of the grants by the concerned Urban Local Body as may happen, should be reported to this Department in good time before the close of the current financial year.

5. The charge is debitable to the head of account "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporations-SP-State Plan(Annual Plan and Eleventh Plan)-005-Development of Municipal Areas-Water Supply facilities(Spot Sources) to the Urban Local Bodies outside CMDA-V-Voted-31-Grants-in-aid-GENERAL-02-Other Grants" under Demand No. 39 (Department Code-MA) in the current year's Budget.

6. This order issues in exercise of the powers delegated under Finance Department's Memo. No. 2450-FB dated 30.12.2011 and as per Finance Department U.O. No.0673 dated 02.08.2011.

7. The Principal Accountant General (A&E), West Bengal and others concerned are being informed.
