Sub: **Release of corresponding State Matching Grant for implementation of Swarna Jayanti Shahari Rozgar Yojana (SJSRY) during 2011-12**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs 4,21,60,334/- (Rupees four crore twenty one lakh sixty thousand three hundred thirty four) only to the State Urban Development Agency for implementation of Swarna Jayanti Shahari Rozgar Yojana (SJSRY) within various Urban Local Bodies of the State during 2011-12.

2. A sum of Rs 4,21,60,334/- (Rupees four crore twenty one lakh sixty thousand three hundred thirty four) only is allotted herewith to meet the expenditure mentioned above.

3. The grants-in-aid sanctioned above will be drawn by the Director, State Urban Development Agency in T.R. Form No. 31 after it is duly counter-signed by the sanctioning authority and will be deposited in the Local Fund Account of the State Urban Development Agency by way of transfer credit. The amount so deposited will be released to the Urban Local Bodies on the basis of the principle adopted in this Department earlier.


4. The Utilization Certificate are required to be furnished by the Urban Local Bodies in terms of SR 330A of the Treasury Rules, West Bengal, Volume - I duly accompanied by physical and financial progress report in the prescribed format to the appropriate authority.




