Subject: Release of fund under Special Backward Region Grant Fund for the Water Supply Schemes for small and medium ULBs.

## MEMO

The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs. 37,25,75,000/- (Rupees thirty seven crore twenty five lakh and seventy five thousand) only to State Urban Development Agency as detailed in the enclosed statement for implementation of the Water Supply Schemes for small and medium ULBs under Special Backward Region Grant Fund as per guidelines circulated earlier under this Department Notification No. 345/MA/C-10/1G-11/2011 dated 16.04.2012.

2. The Director, SUDA is authorized to draw the amount sanctioned in para 1 above in T.R. Form No. 43 and place the same to its Local Fund Account by transfer credit. Subsequently Director, SUDA will disburse the same to the concerned Urban Local Bodies by transfer credit to their local fund account with the treasuries concerned for implementation of the Schemes in accordance with the guidelines issued by the Government for the purpose.

3. The State Urban Development Agency (SUDA), before transferring the fund to the concerned ULBs must ensure that proper tender process has been followed and work order has been issued to the contractors.

4. The State Urban Development Agency (SUDA), while transferring the fund to the Local Fund Account of the concerned ULBs must consider only the required amount needed for execution of the schemes.

5. The charge is debitable to the heads of account under Demand No. 39/MA in the current year's budget, as detailed below:-

6. The State Urban Development Agency (SUDA) is to act as the State Level Nodal Agency (SLNA).

7. The concerned ULBs shall maintain a separate account for funds released to them under Special BRGF so that the utilization certificate showing actual expenditure and also physical progress may be sent to Government of India.

8. Utilization Certificates in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I as well as in Form GFR 19-A, are to be furnished by the Urban Local Bodies regularly to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department, concerned District Magistrates as well as the State Urban Development Agency.

9. The information of drawal / non-drawal of the grant by the concerned local bodies, as may happen, should be reported to this Department immediately.

10. This order issues in exercise of the powers delegated under Finance Department Memo No. 1700-F.B. dated 31.12.2012 and with the concurrence of the Finance Department vide their U.O. No. Gr. 'N' 2722 dated 18.3.2013.


