I am directed by order of the Governor to say that the Governor has been pleased to accord sanction and release to the payment of Rs. 74,74,000/- (Rupees Seventy four lakhs seventy four thousand) only as loan component of Additional Central Assistance to the Kolkata Municipal Corporation under "Reimbursement Procedure" for implementation of the Kolkata Environmental Improvement Project (Asian Development Bank assisted programme under Loan No. 1813-IND) in terms of Department of Expenditure, Ministry of Finance, Plan Finance-I Division, Government of India sanction letter no. F. No. 53(1)/PFI/2012-774 dated 16.10.2012.
