Sub: **Fixed Grant to the Municipal Corporation towards Salaries of their employees for the month of June, 2011 with arrear if any.**

The undersigned is directed by order of the Governor to say that the Governor is hereby pleased to sanction and release for payment of a sum of Rs. 4,37,13,996/- (Rupees four crore thirty-seven lakh thirteen thousand nine hundred ninety six) only to the Corporations as per enclosed statement for payment of salaries to their regular employees for the month of June, 2011, subject to the following conditions:

1. Grant shall be utilized towards the regular employees of the Municipal Corporations who are in position and whose appointment have been approved by the State Government, alongwith the contractual person-in-position in accordance with G.O. No. 114/MA/O/C-9/2A-13/2010 dated 25.02.2011 whose continuity have been communicated by ULB to the administrative department till date.
2. If on verification any material discrepancies in the number of posts sanctioned and the number of employees in position against the sanctioned strength are detected at any later stage, appropriate adjustment in grant to be released subsequently on the account will be made.
3. Any over payment or under payment in this regard will be adjusted from the grants to be released for this purpose later.
4. The Grants-in-aid sanctioned herein will be drawn by the Commissioner, of concerned Municipal Corporation after it is duly countersigned by the District Magistrate of concerned district. The Commissioner of respective Municipal Corporation will be the operator of the fund.
5. The charge is debitible to the head, "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporations-NP-Non-Plan-019-Fixed Grants to the Municipal Corporation and other Urban Local Bodies, towards Salaries of their employees-31-Grants-in-aid-GENERAL-01-Salary Grants-V" under Demand No.39/MA in the current year's vote-on-account budget i.e. 2011-2012.
6. The Utilisation Certificate in respect of the grant to be drawn by the Local Body should be submitted in the prescribed form in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, Volume-I, direct to the Principal Accountant General (A&E), west Bengal, with a copy of the same to the Department in the prescribed proforma, as soon as the amount is drawn and utilised for the purpose for which it is sanctioned.
7. Utilisation Certificate upto May, 2011 must be produced for further release of fund.
8. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
9. This order issues in exercise of the powers delegated under Finance Department Memo No. 700-FB dated 31.03.2011.
