Sub: Release of Fixed Grant to the Municipal Corporation and other Urban Local Bodies (Excluding Kolkata Municipal Corporation & Howrah Municipal Corporation) during 2011-2012 for the month of April, 2011 (1st instalment) with arrear if any.

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment on ad-hoc basis to the Municipal Corporation and other Urban Local Bodies (Excluding Kolkata Municipal Corporation & Howrah Municipal Corporation) a sum of Rs.6,86,30,937/- (Rupees six crore eighty six lakh thirty thousand nine hundred and thirty seven) only as per enclosed statement as Fixed Grant (1st instalment) for the month of April, 2011 during the year 2011-2012 with arrear, if any.

2. Such fund should not be utilised towards implementation of any developmental schemes. The District Magistrate will also ensure that no publicity / announcement, accompanied by or associated with these transfer of fund is made and they will further ensure that these fund will obviously be used for the purpose for which the sanction is made and not for any other purposes.

3. The District Magistrate is hereby authorised to draw the amount sanctioned above and disburse the same by transfer credit through Local fund Account of the respective Urban Local Bodies.

4. The charge is debitible to the head, "3604-Compensation and Assignments to Local Bodies and Panchayati Raj Institutions-00-200-Other Miscellaneous Compensation & Assignments-NP-Non-Plan-034-Fixed Grants to Municipal Corporations and other Urban Local Bodies - 31-Grants-in-Aid-GENERAL-02-Other Grants-V" under Demand No. 39/MA in the current year's vote-on-account budget i.e. 2011-2012.

5. The Grants-in-aid sanctioned above, Utilisation Certificate is to be furnished by the Municipal Corporation and other Urban Local Bodies in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, Volume-I direct to the Principal Accountant General (A&E), West Bengal with a copy to this Department, as soon as the amount is drawn and utilised. Submission of Utilisation Certificate upto March, 2011 is required for further release of fund.

6. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.

7. This order issues in exercise of the powers delegated under Finance Department Memo No. 700 - FB dated 31.03.2011.


