The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs.10,00,000/-(Rupees ten lakh) only in favour of Sainthia Municipality for "Construction of Cement Concrete Road from Satya's Mill to Malberia in ward no.7" under Development of Municipal Areas(Municipalities) Scheme.

2. The District Magistrate concerned is authorised to draw the amount sanctioned in para 1 above in T.R. Form No. 31 and disburse the same to the concerned Urban Local Body by transfer credit to its Local Fund Account with the Treasury concerned for the purpose mentioned above.

3. The Utilisation Certificate in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Body to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department, the concerned District Magistrate as well as the State Urban Development Agency.

4. A list of the scheme undertaken showing its name, location, estimate and expenditure incurred should invariably be furnished to State Urban Development Agency.

The amount is debitable to the head of account, "2217-Urban Development-05-Other Urban Development Schemes-192-Assistance to Municipalities / Municipal Councils-SP-State Plan (Annual Plan and Eleventh Plan)-006-Development of Municipal Areas(Municipalities)-V-Voted-31-Grants-in-aid-GENERAL-02-Other Grants" under Demand No. 39/MA in the current year's vote-on-account budget.
