**Sub : Release of fund under Water Supply Facilities (Spot Sources) in favour of the Urban Local Bodies.**

As per the latest status report received from the SUDA, a sum of Rs.4,95,25,000/- (Rupees Four crore ninety five lakh and twenty five thousand) only was the balance amount lying with the SUDA, out of the sums deposited into its Local Fund Account under this Department G.O.No.436/MA/P/C-10/1G-4/2004(FS) dated 08.03.2006 and 457/MA/P/C-10/1G-4/2004(FS) dated 22.03.2006 and also out of the sums since refunded by a number of District Magistrates under the above mentioned Head of Account.

Out of this a sum of Rs.25,00,000/- (Rupees twenty five lakh) only allocated to Bally Municipality vide this Department's G.O.No.943/MA/P/C-10/1G-4/2004 Pt.I dated 09.08.2007, and Rs.10,00,000/- (Rupees Ten lakh) only allocated to Dankuni Municipality vide this Department G.O.No.1122/MA/P/C-10/1G-4/2004 Pt.I dated 28.11.2008 and Rs.60,00,000/- (Rupees Sixty lakh) only allocated to Ashokenagar-Kalyangarh Municipality and Purulia Municipality vide this Department G.O.No.136/MA/P/C-10/1G-4/2008 dated 02.03.2009, leaving a balance of Rs.4,00,25,000/- (Rupees Four crore and twenty five thousand) only.

2. The undersigned is now directed by order of the Governor to state that the Governor is pleased to sanction payment of a sum of Rs.4,00,00,000/- (Rupees four crore) only in favour of the Urban Local Bodies as detailed in the enclosed statement.

3. The Director, State Urban Development Agency is hereby authorized to draw the Bank Draft/Local Fund Account Payee Cheques amounting to Rs.4,00,00,000/- (Rupees four crore) only in total in favour of the concerned Urban Local Bodies for the purpose indicated herein above at para-2, leaving a balance of Rs.25,000/- (Rupees twenty five thousand) only.

4. The concerned Urban Local Bodies will submit their Utilization Certificate(s) in terms of S.R.330A of Treasury Rules, West Bengal, Vol.I to the Principal Accountant General (A&E), West Bengal with a copy of each endorsed to the concerned District Magistrates, this Department and to the State Urban Development Agency.
