Subject: Payment of Fixed Grant to the Notified Area Authority and other Urban Local Bodies for Dearness Allowance to their employees for the month of **June, 2011** with arrear, if any on revised basic pay as per ROPA, 2009 on provisional basis.

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release a sum of **Rs.4,58,450/- (Rupees four lakh fifty eight thousand four hundred and fifty)** only to the Notified Area Authority as stated against each in the enclosed statement as grants for Payment of Dearness Allowances to their regular employees for the month of **June, 2011** on revised basic pay as per ROPA, 2009.

2. The Grants-in-aid sanctioned herein above will be drawn by the concerned District Magistrate and will disburse the same to the Urban Local Bodies in his jurisdiction by transfer credit through Local fund account to the concerned Notified Area Authority.

3. The charge is debitible to the head, "2217-Urban Development-05-Other Development Scheme-193-Assistance to Nagar Panchayats / Notified Area committee or equivalent thereof-NP-Non-Plan-007-Dearness Concession to the employees of Notified Authorities-31-Grants-in-Aid-GENERAL-01-Salary Grants-V" under Demand No. 39/MA in the current year's i.e.2011-2012 vote-on-account budget. The excess drawal will be adjusted for the current financial year by way of re-appropriation or otherwise in due course.

4. The Utilisation Certificate in respect of the grant to be drawn by the Notified Area Authorities should be furnished in the prescribed form direct to the Principal Accountant General (A&E), West Bengal with a copy to this Department, as soon as the amount is drawn and utilised. Submission of Utilisation Certificate upto **May, 2011** must be necessary for release of further fund.

5. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.

6. This order issues in exercise of the powers delegated under Finance Department Memo No. 700 – FB dated 31.03.2011.
