The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs. 4,55,000/- (Rupees four lakh fifty five thousand) only in favour of Mirik Notified Area Authority for construction of Cement Concrete Road from N.B. Subba's house to Prem Rai's house at Deosay Dara, Ward No. IV under Development of Notified Areas Scheme.

2. The District Magistrate concerned is authorised to draw the amount sanctioned in para 1 above in simple receipt Form (New T.R. Form 31) and disburse the same to the concerned Urban Local Body by transfer credit to its Local Fund Account with the Treasury concerned for the purpose mentioned above.

3. Utilisation Certificate in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Body to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department as well as to the State Urban Development Agency.

4. A statement of estimates and expenditure incurred should invariably be furnished to State Urban Development Agency.

The amount is debit to the head "2217-Urban Development-05-Other Urban Development Schemes-193-Assistance to Nagar Panchayats / Notified Area Committees or equivalent thereof-SP-State Plan (Annual Plan and Eleventh Plan)-006- Development of Notified Areas-V-Voted-31-Grants-in-aid-02-Other Grants" under Demand No. 39/MA in the current year's vote-on-account budget.
