**Subject : Payment of grants for tackling water scarcity to the Mirik Notified  
Area Authority under State Plan during the year 2008-2009.**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs. 17,02,000/- (Rupees Seventeen lakh two thousand ) only to the Mirik Notified Area Authority for augmentation of Water Supply Scheme.

2. The District Magistrate concerned is authorised to draw the amount sanctioned herein and disburse the same to the Mirik Notified Area Authority by transfer credit to its Local Fund Account with the Treasury concerned. The Urban Local Body will utilise the said amount for the purpose for which it is sanctioned.



He is further requested to obtain the Utilisation Certificate in respect of the amount sanctioned herein in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I, from the concerned Urban Local Body and to submit a copy of the same direct to the Principal Accountant General, West Bengal and also to this Department after satisfying himself about the authenticity and accuracy of the same as early as possible. Further funds will not be released if Utilisation Certificates for release made earlier including this amount are not received within June, 2008, wherever applicable.

4. The fact of drawal or non-drawal of the grants by the concerned Urban Local Body, as may happen, should be reported to this Department in good time before the close of the current financial year.

5. The charge is debitable to the head, "2217-05-191-SP-005-V-31-02" under Demand No. 39(Department Code- MA), in the current year's Vote-on-Account Budget.

6. This order issues in exercise of powers delegated under Finance Department Memo No. 2320-F.B dated 31.03.2008.


