MEMORANDUM

The undersigned is directed by order of the Governor to say that the Governor has been pleased to sanction and release a sum of Rs. 1,25,00,000/- (Rupees One crore twenty five lakhs) only to the State Urban Development Agency for meeting O & M expenses for IPP-VIII, IPP-VIII(Extension) and RCH sub-project, Asansol activities beyond the project period for incurring expenditure towards procurement of drug during the period from April, 2011 to July, 2011 under the Vote-on-Account budget of the current financial year (2011-2012).

2. The sum of Rs. 1,25,00,000/- (Rupees One crore twenty five lakhs) only is allotted herein to the State Urban Development Agency to meet the expenses mentioned in para-1 above.
3. The amount sanctioned and released above may be drawn by the Director, SUDA in T.R. Form No. 31 after it is duly countersigned by the sanctioning authority and will be deposited in the Local Fund Account of SUDA. The amount so deposited will be released by the SUDA in favour of its health wing for utilization for the purpose mentioned above.
4. The charge is debitible to the Head of Account, "2211-Family Welfare-00-108-Selected Area Programmes(Including India Population Project)-SP-State Plan (Annual Plan & Eleventh Plan)-005-Implementation of IPP VIII in Kolkata Metropolitan District & Other Municipal Towns [MA]-31-Grants-in-aid-GENERAL-02-Other Grants" (Code: 2211-00-108-SP-005-31-V-02) under Demand No. 39 and Departmental Code MA from the Vote-on-Account budget of the current financial year (2011-2012).
5. The utilization Certificate in the prescribed format in respect of the aforesaid amount should be furnished to the Principal Accountant General (A&E), West Bengal with a copy to this Department.
6. This order issues with the concurrence of the Finance Department vide their U.O. No. Gr. 'R' 11 dated 15.06.2011 and in terms of Finance Department, Budget Branch Memo. No. 700-F.B. dated 31.03.2011.
7. The Principal Accountant General (A&E), West Bengal and all other concerned are being informed.
